This document defines the policy with regard to activities of the State enterprise "BSCA" (hereinafter - BSCA, the accreditation body), accreditation schemes.

This policy is developed to further p. 4.6.1 GOST ISO/IEC 17011 (ISO/IEC 17011, IDT) in accordance with document EA 1/06 A-AB.

Policy applies to BSCA activities, applicants for accreditation and accredited CABs.

- **1.** BSCA conducts assessments of conformity assessment bodies (hereinafter CABs), that performs conformity assessment activities, including:
 - testing;
 - calibration;
 - medical testing;
 - inspection;
 - certification of products and services;
 - certification of management systems;
 - certification of persons;
 - proficiency testing providers.
- **2.** As a signatory to the European co-operation for Accreditation Bilateral agreement (EA BLA); the International Accreditation Forum Multilateral Agreement (IAF MLA) in the following scopes: certification of products, persons, management systems; the International Laboratory Accreditation Cooperation Mutual Recognition Agreement (ILAC MRA) in the in the following scopes: testing and calibration, BSCA meets the requirements of the mandatory documents EA, ILAC, IAF, given in Annex 1.
- **3.** During the accreditation cycle accredited CABs shall continually fulfill the accreditation requirements set out in the relevant standards and documents ILAC, EA, IAF in accordance with Annexes 2-9 and provide evidences of fulfillment of these requirements.
- **4.** Accredited testing, calibration and medical laboratories shall participate in proficiency testing programs during the accreditation cycle in relation to the entire scope of accreditation in accordance with the PL SM 7.15.
- **5.** After accreditation is granted to the conformity assessment body, BSCA conducts surveillance assessments, the purpose of which is to assess the continuous implementation by the conformity assessment body of all accreditation requirements. Surveillance assessments are carried out in accordance with the program of assessments for the accreditation cycle in accordance with the procedure established by Chapter 8 of the Accreditation Rules. If the accredited conformity assessment body conducts its activities on various sites, BSCA during the accreditation cycle carries out a competence assessment on each of them.
- **6.** BSCA conducts an assessment of the competence of the conformity assessment body for the purpose of re-accreditation according to the program of assessments for the accreditation cycle in accordance with the procedure established by Chapter 4 of the Accreditation Rules. When re-accrediting, BSCA takes into account information obtained from the results of assessments during the previous accreditation cycle.

- 7. The competence assessment of the conformity assessment body for the purpose of accreditation in the additional field of accreditation is carried out in accordance with the procedure established by Chapter 5 of the Accreditation Rules. Accreditation in an additional scope of accreditation may be associated with new types of conformity assessment activities within the current scope of accreditation, new locations, expanding for specific areas, for example, development, modification and validation of methods. Accreditation in the additional scope of accreditation can be carried out in conjunction with the planned surveillance, re-accreditation at the request of the conformity assessment body.
- **8.** If there are complaints about the activities of the conformity assessment body, changes or other cases arise that may affect the ability of the conformity assessment body to comply with accreditation requirements, the BSCA conducts unscheduled assessments of competence.



Criteria for the accreditation body activities

BSCA accredits legal entities of the Republic of Belarus or foreign legal entities that have expressed a desire to receive confirmation of their competence in performing conformity assessment activities in accordance with p. 1 of this document.

In carrying out its activities BSCA is guided by the following documents:

BSCA accredits legal entities of the Republic of Belarus or foreign legal entities that carry out activities for testing food and agricultural products, pharmaceutical products, chemical products (including petroleum products and fuel), environmental facilities, industrial facilities, furniture products, building materials and products, structures, light industry products, perfumes and cosmetics, personal protective equipment, electrical equipment, transport tools, machinery and equipment, products and systems (objects of assessment) of information technology, technical devices used in the field of industrial safety, the safety of the transport of dangerous goods and other products.
