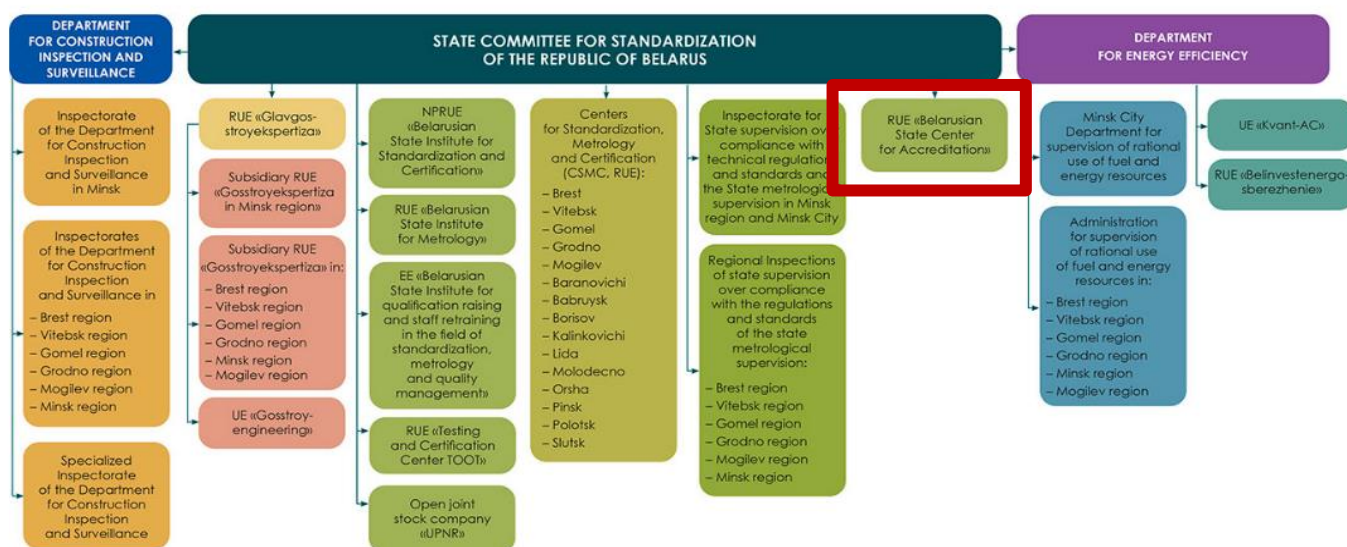

Structure of the National Accreditation System of the Republic of Belarus includes as follows:

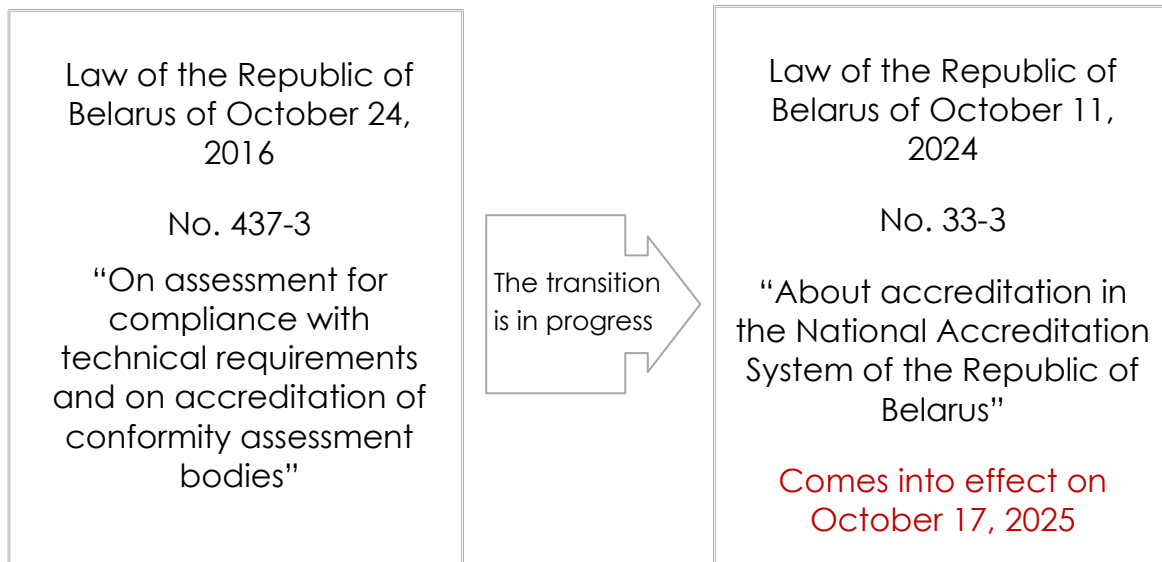
- the State Committee for Standardization of the Republic of Belarus

In accordance with cl.2 of the Accreditation Rules "In the National Accreditation System of the Republic of Belarus accreditation shall be carried out by the accreditation body named the Republican Unitary Enterprise "The Belarusian State Centre for Accreditation", which is subordinate to the State Committee for Standardization".

LEGAL BASIS OF THE NATIONAL SYSTEM OF ACCREDITATION OF THE REPUBLIC OF BELARUS



Subordinate legislation:

- the Accreditation Rules that are approved by Decree of the State Committee for Standardization of the Republic of Belarus No. 27 of May 31, 2011 (as amended by Gosstandart Decree No. 39 of June 26, 2019 and Gosstandart Decree No. 102 of December 22, 2020);
- Rules for maintaining the Register of the National Accreditation System of the Republic of Belarus are set by Decree of the State Committee for Standardization of the Republic of Belarus No. 41 of May 26, 2017.

Accreditation ensures compliance with the Treaty on the Eurasian Economic Union and the Union's acts in the field of accreditation and conformity assessment, current versions of interstate standards in the field of accreditation and conformity assessment, developed on the basis of current versions of international standards, as well as documents of the International Laboratory Accreditation Cooperation and the International Accreditation Forum.

The Belarusian State Centre for Accreditation has been a member of the International Laboratory Accreditation Cooperation (ILAC) since 2011 and a signatory to the ILAC MRA multilateral agreement on mutual recognition in the field of accreditation:

- testing laboratories
- calibration laboratories
- medical laboratories
- inspection bodies
- proficiency testing providers



The right to apply combined ILAC MRA mark on the conformity assessment documents is given to:


- 163 testing laboratories;
- 6 calibration laboratories.

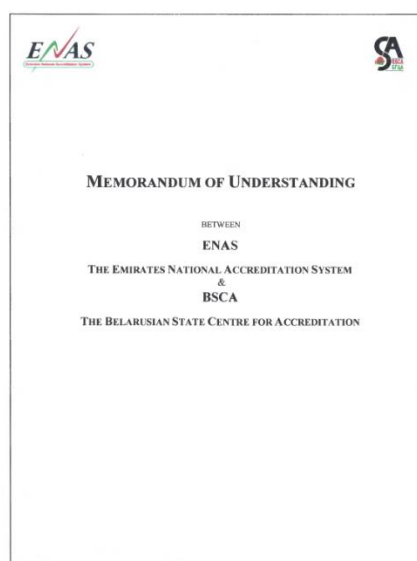
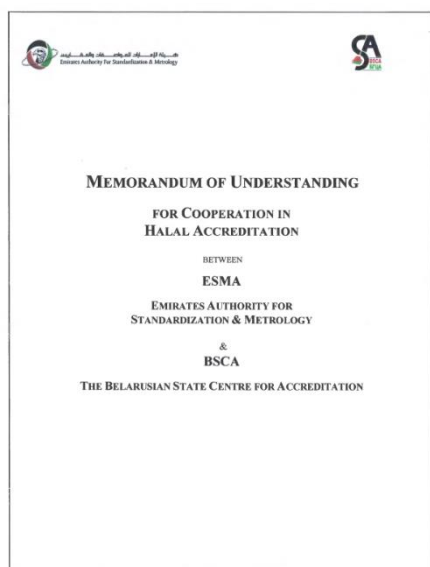

INTERNATIONAL RECOGNITION OF ACCREDITATION OF HALAL CERTIFICATION BODIES

Since 20.10.2019, BSCA is a full member of the International Halal Accreditation Forum.



To develop its membership in IHAF, BSCA signed memoranda of cooperation and understanding with the Emirates National Accreditation System (ENAS) and the Emirates Authority for Standardization and Metrology (ESMA).



Bilateral cooperation with the UAE allows for the involvement of experts on Islamic issues in the BSCA assessment team, and ensures that the national legislation of the UAE is taken into account when accrediting Belarusian halal certification bodies. As a result of cooperation with the UAE:

- BSCA is included in the register of accreditation bodies recognized in the UAE;
- certificates of Belarusian halal certification bodies are recognized in the UAE and other regions of the Persian Gulf (Kingdom of Saudi Arabia, Bahrain, Qatar, Kuwait, Oman, Iraq, Iran).

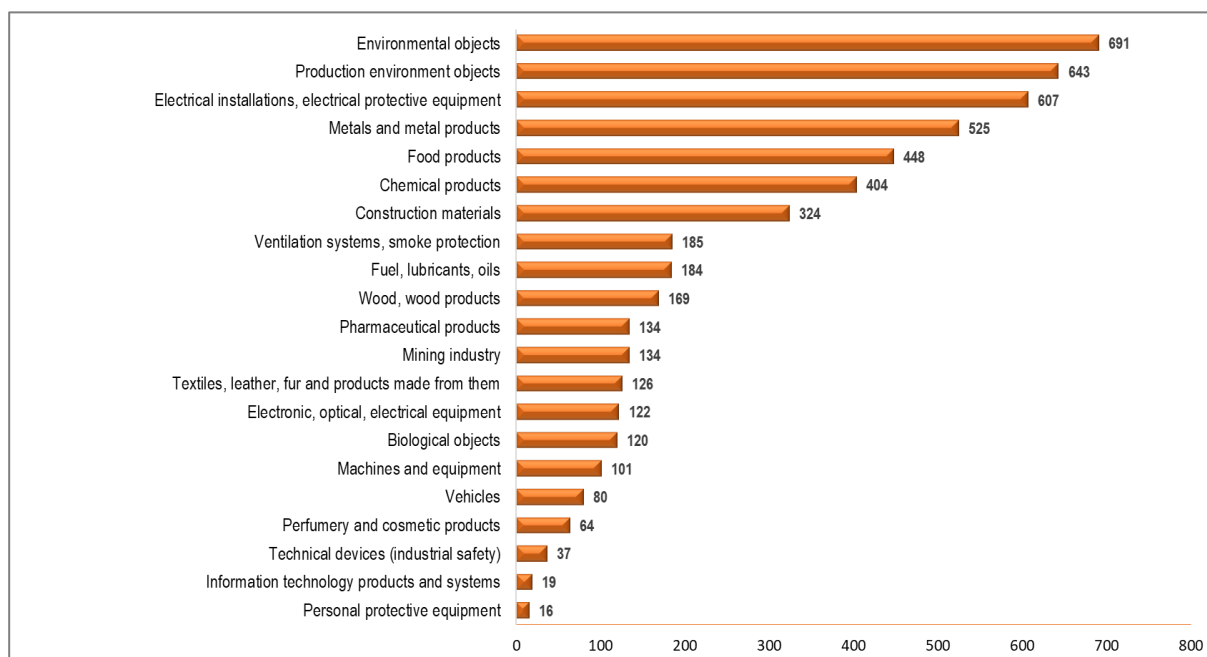

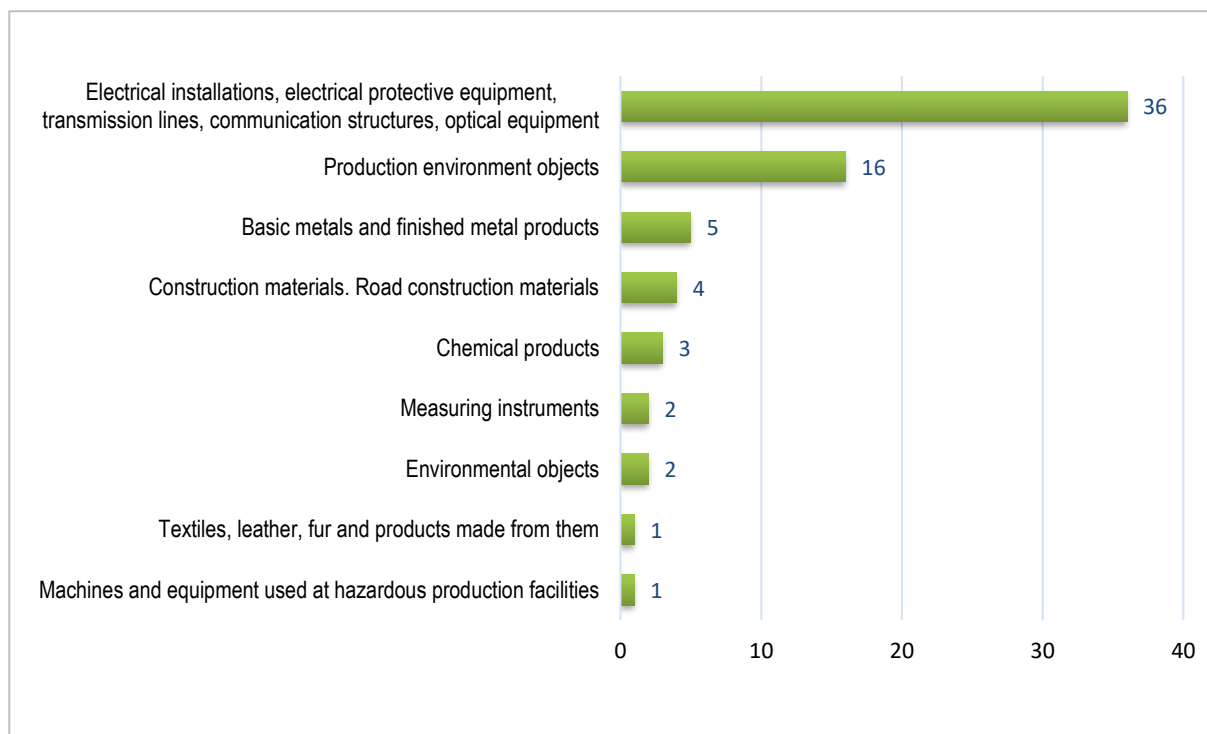

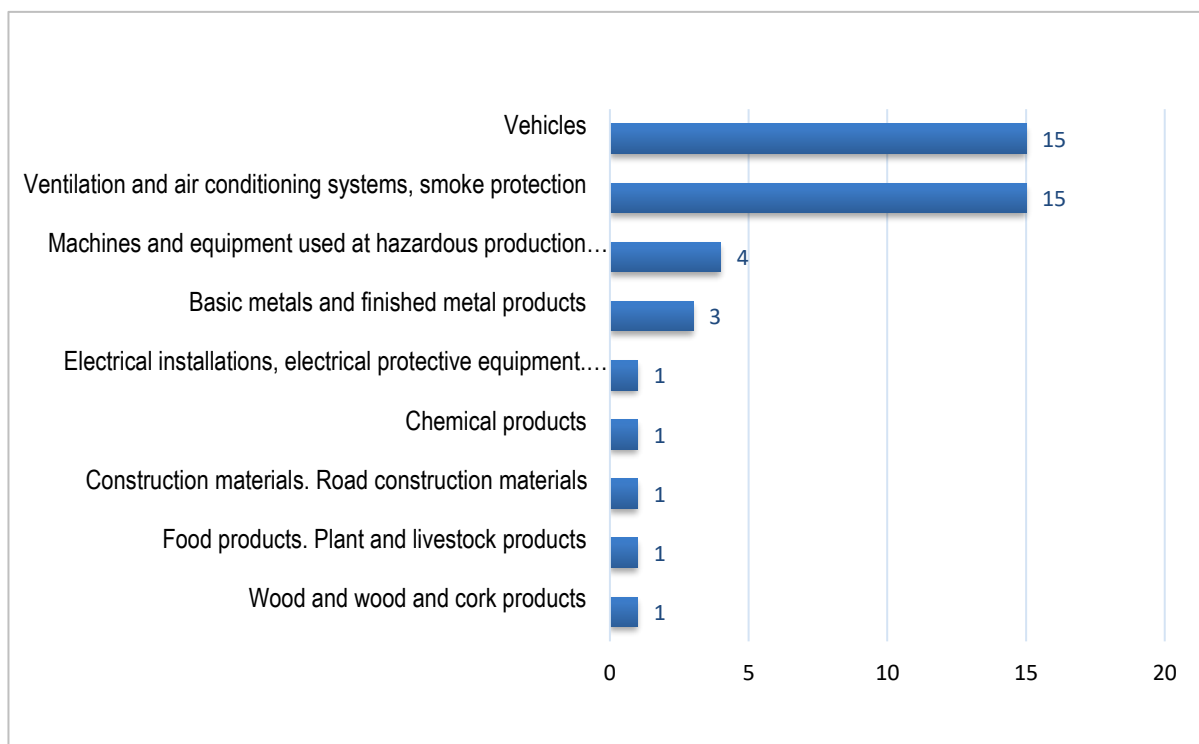
SCOPES OF ACTIVITY OF ACCREDITED TESTING LABORATORIES



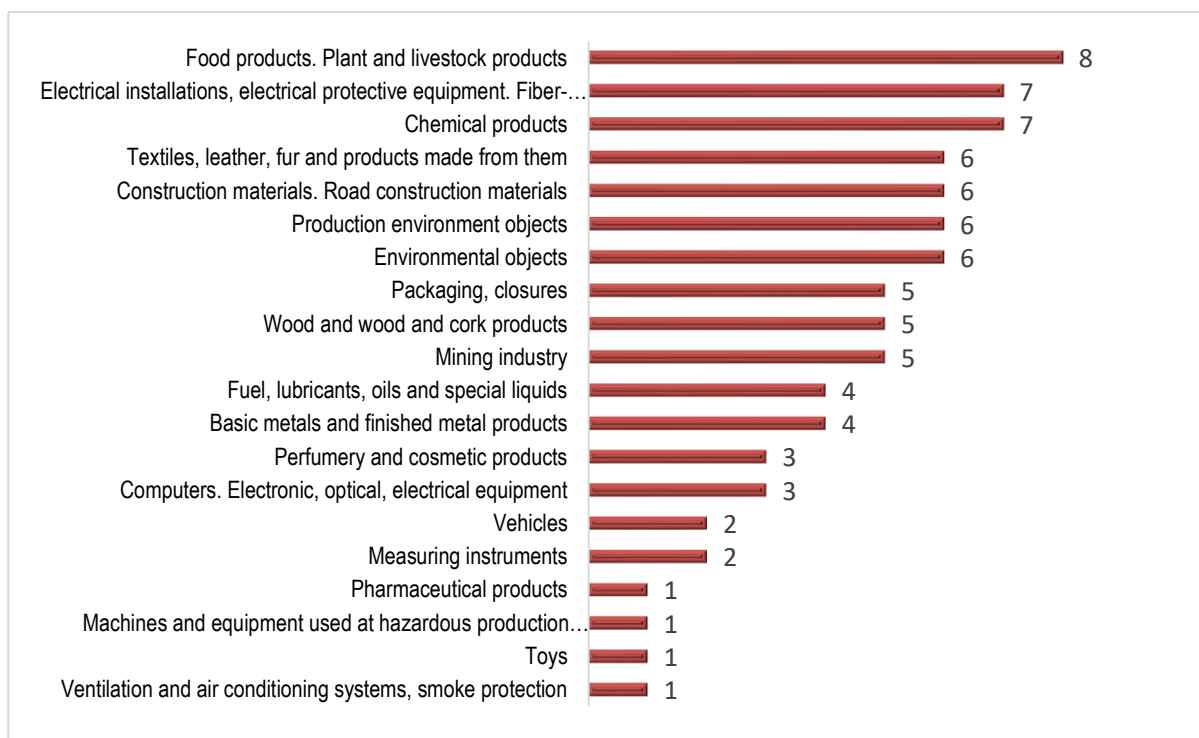
SCOPES OF ACTIVITY OF ACCREDITED MEASURING LABORATORIES



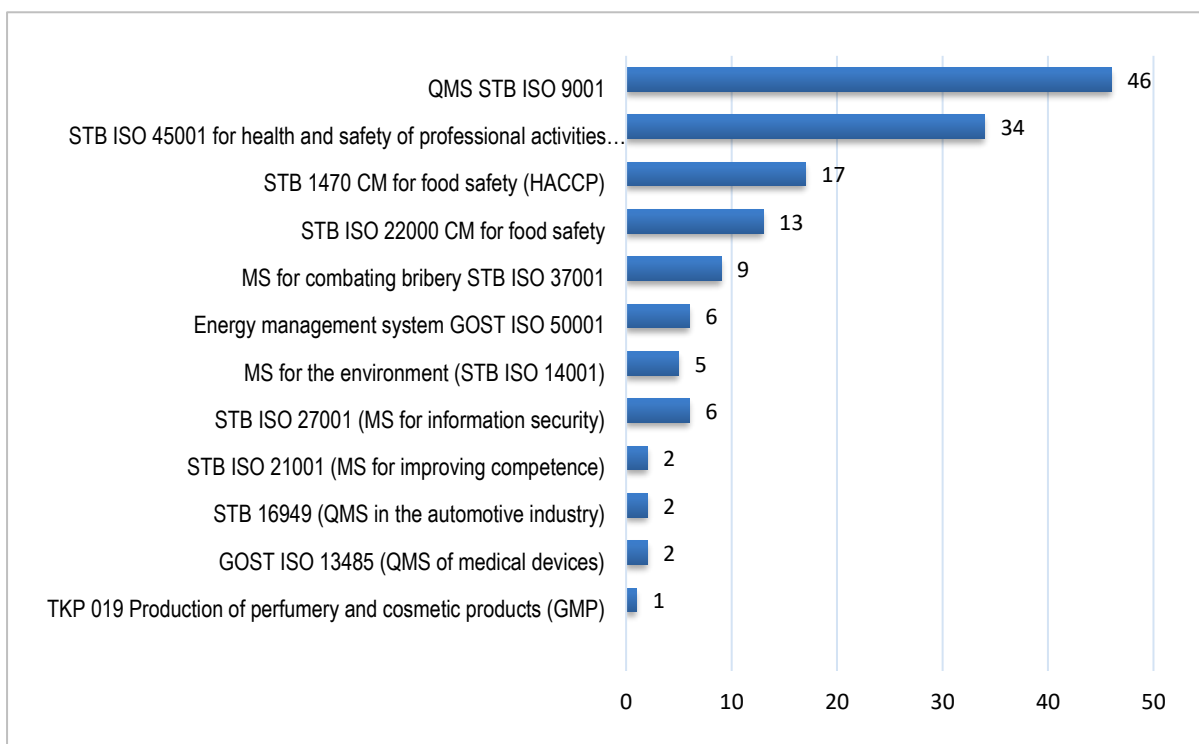
SCOPES OF ACTIVITY OF ACCREDITED INSPECTION BODIES



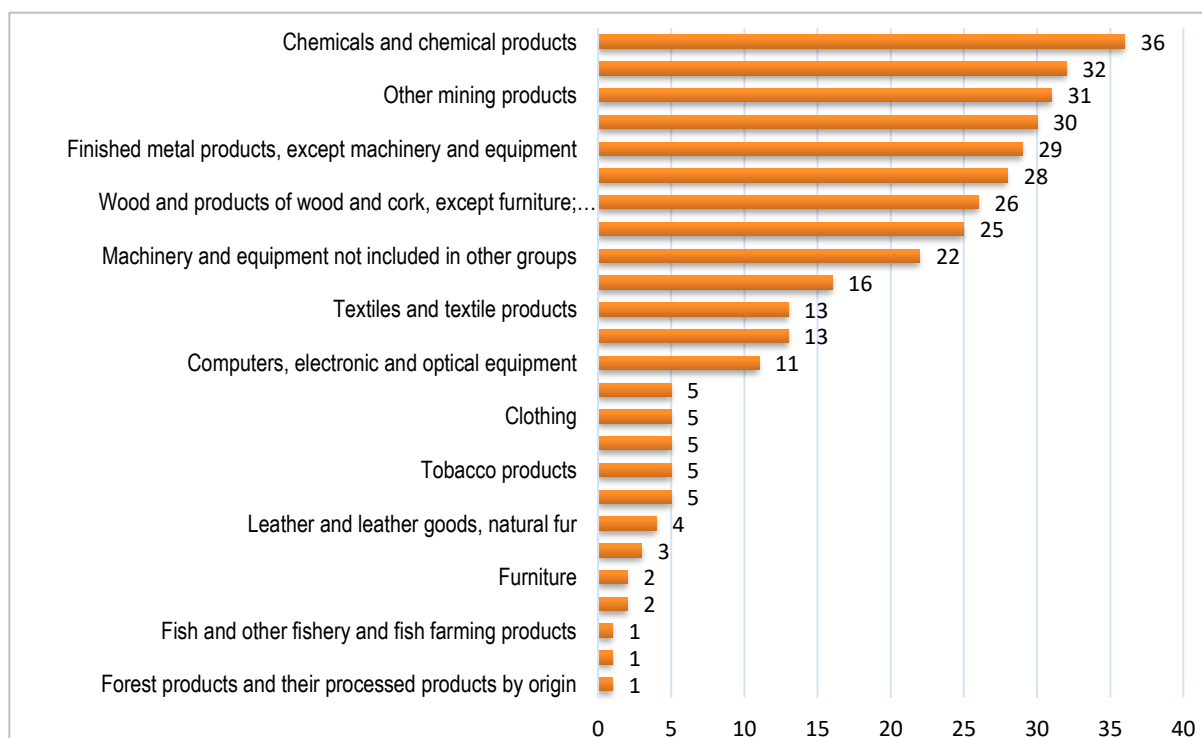
SCOPE OF ACTIVITY OF ACCREDITED PROFESSIONAL TESTING PROVIDERS



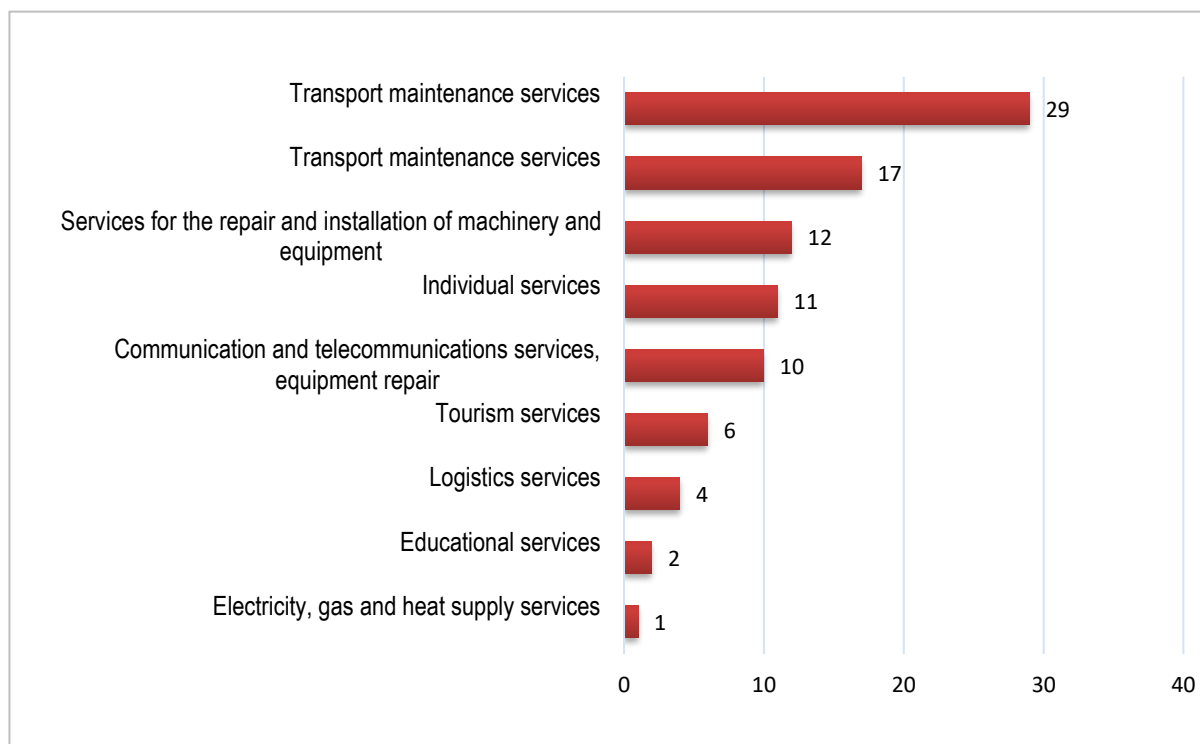
SCOPES OF ACTIVITY OF ACCREDITED MANAGEMENT SYSTEM CERTIFICATION BODIES



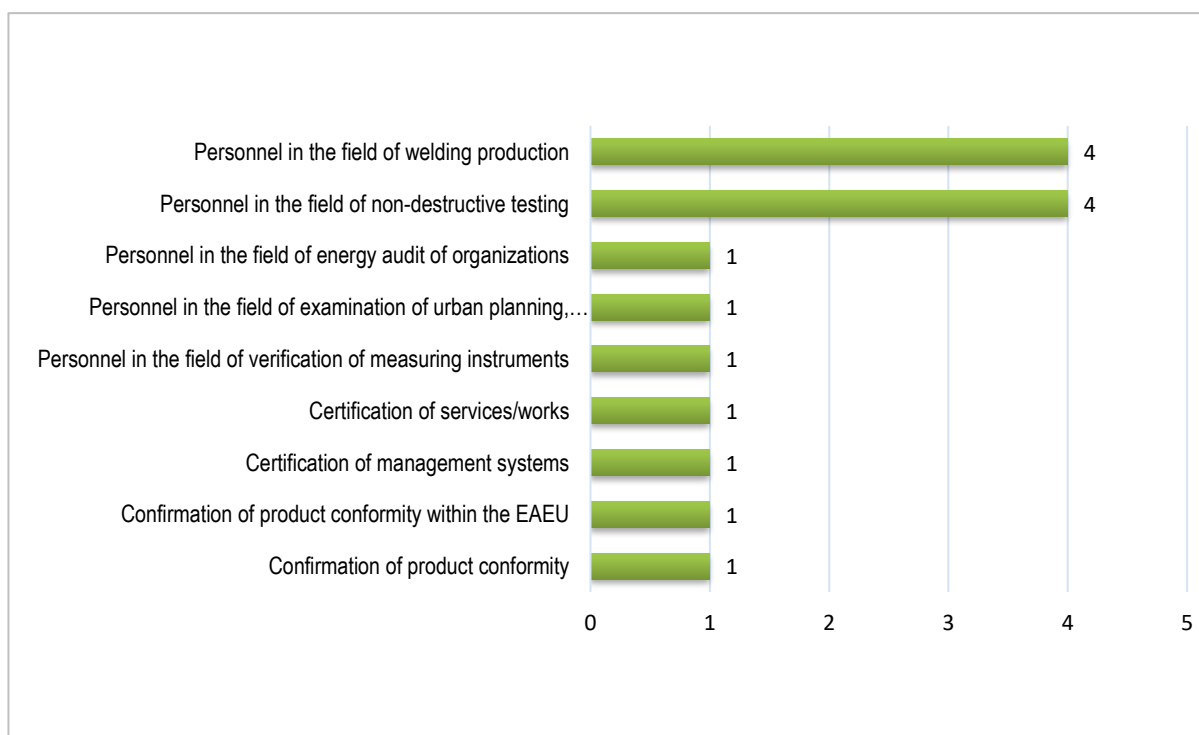
SCOPES OF ACTIVITY OF ACCREDITED PRODUCT CERTIFICATION BODIES



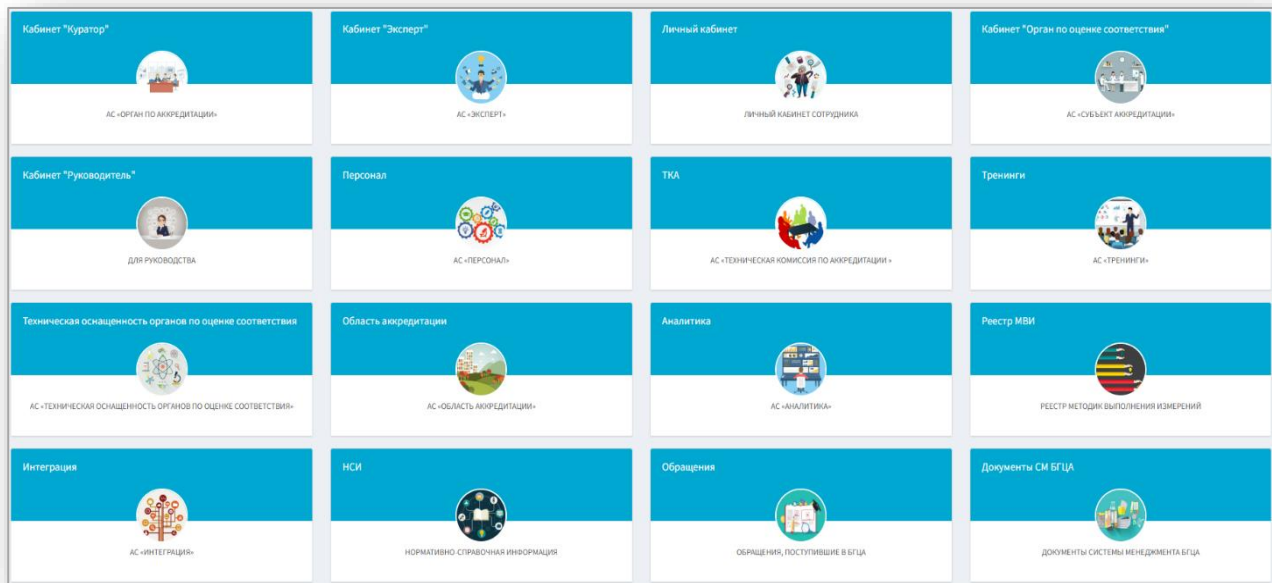
SCOPES OF ACTIVITY OF ACCREDITED BODIES FOR CERTIFICATION OF SERVICES/WORKS

TECHNICAL COMMITTEES ON ACCREDITATION

*Technical Committees on Accreditation are collegial bodies created by the accreditation body to develop **methodological recommendations** on issues related to the implementation of accreditation, determining requirements for the professional competence of assessors, technical assessors, certification of assessors, verification of the special knowledge and skills of technical assessors for inclusion in the register of technical assessors, as well as for **submitting recommendations to the accreditation body** regarding decisions taken on accreditation, conducting verification of the special knowledge and skills of technical assessors for inclusion in the register of technical assessors*

TECHNICAL COMMITTEE No. 1: Testing laboratories for food and agricultural products, research of biological objects, materials, liquids. Pharmacy, perfumery and cosmetic products and anti-doping control. Medical laboratories.

TECHNICAL COMMITTEE No. 2: Testing (research) laboratories for measurements in the field of environmental protection and labour protection; light industry products; wood and paper products; printed products, furniture, toys; mining products, petroleum products, chemical products, rubber and plastic products.

TECHNICAL COMMITTEE No. 3: Testing laboratories for electrical, electrotechnical and electronic equipment; electrical installations and protective equipment; fiber-optic transmission lines; vehicles; machinery and equipment; pyrotechnic products; explosives and non-destructive testing.

TECHNICAL COMMITTEE No. 4: Testing laboratories for testing (measurements) of building materials and products, installations, buildings and structures; highways, road structures, road construction materials and products; personal protective equipment, fire safety and fire extinguishing equipment; metals and alloys, ready-made metal products.

TECHNICAL COMMITTEE No. 5: Verification and calibration laboratories. Proficiency testing providers.

TECHNICAL COMMITTEE No. 6: Bodies for certification of management systems (management systems), products and services (works), personnel and forest certification.

TECHNICAL COMMITTEE No. 7: Construction inspection; vehicle inspection; technical diagnostics (technical examination) of technical devices, equipment and vehicles; inspection in the field of transportation (movement) of goods, including dangerous ones.
